This programme allows students to have a credit-transfer option by studying two years in UCTS and finishing the remaining years in Birmingham, getting the full UK MEng degree from the University of Birmingham for a more affordable fee.

# TRANSFER DEGREE PROGRAMME

## Programmes:

- Civil Engineering
- Electrical Engineering
- Mechanical Engineering

## Requirements:

- Minimum UCTS CGPA 3.0
- One of the following:
  - IELTS: 6.0 overall (minimum 5.5 band score);
  - TOEFL: 80 overall with no less than 19 in Reading, 19 in Listening, 21 in Speaking and 19 in Writing
  - PTE: 51 in all four skills
  - SPM 1119 English: Grade C

## Cost Estimation (British Pound):

- Tuition Fees - **£23,400 per year (2020-21 academic year fee)**
  - **20% tuition fee scholarship offered to all UCTS students, in both years of study**
- Accommodation - **University accommodation from under £100 per week**
  - **Off campus accommodation available in the City of Birmingham**

- **2 years UCTS + 2 years UoB**

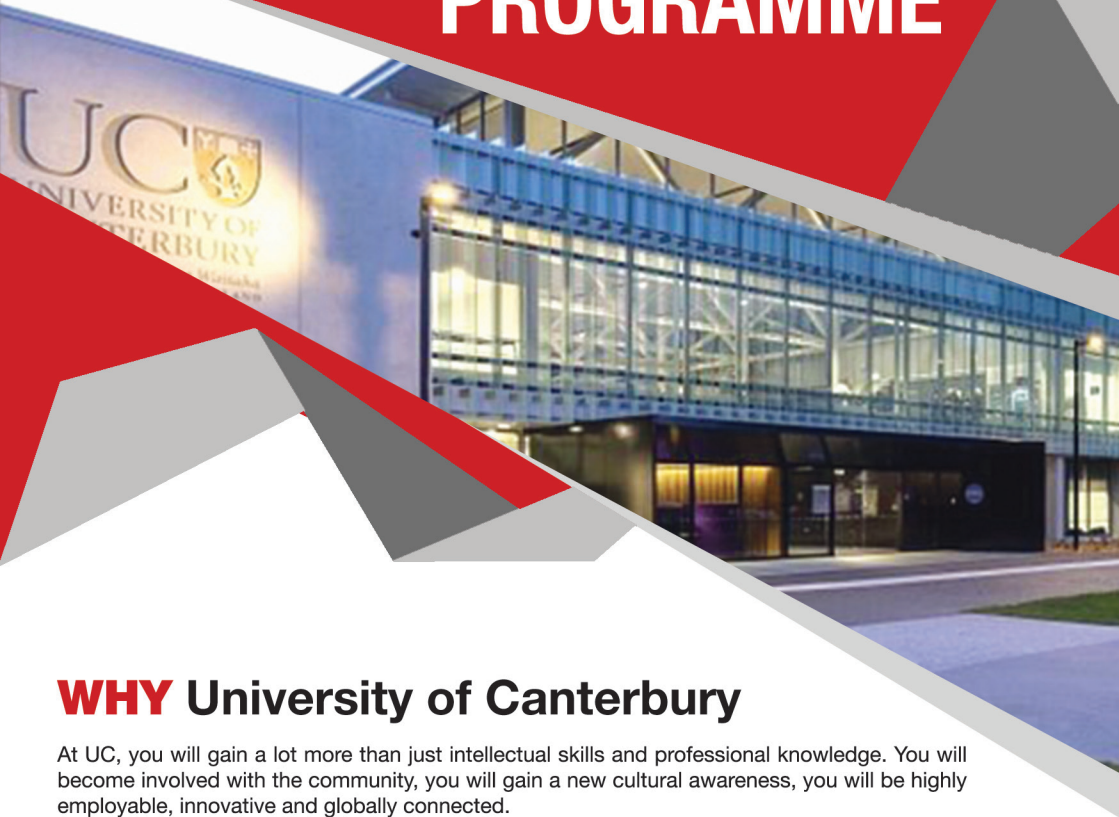

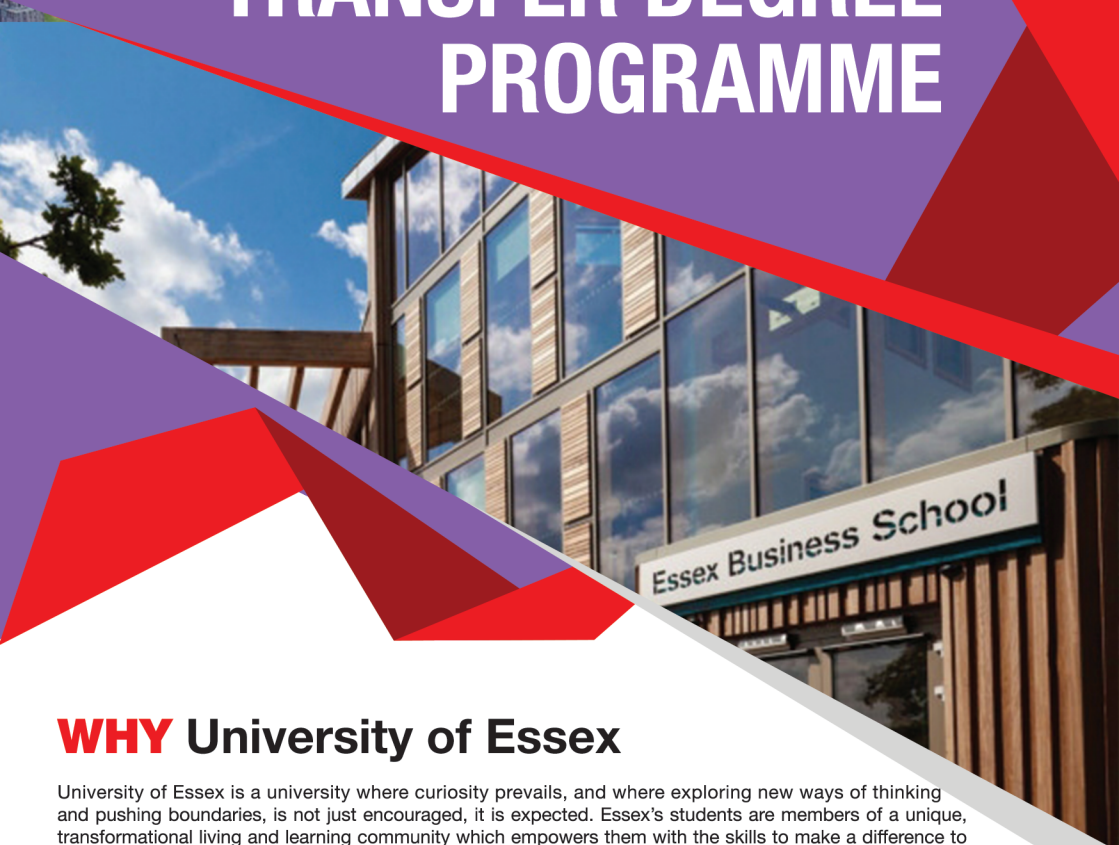
